

Container Recycling Program with CleanEarth™

WeatherBond has partnered with Clean Earth to offer an exclusive program that provides a low-cost and eco-friendly disposal option for empty CAV-GRIP® III, CAV-GRIP PVC, CAV-PRIME V-150 Primer, CAV-PRIME Low-VOC EPDM and TPO Primer, CAV-PRIME TPO Primer, and Flexible DASH™ Dual Tanks, 15-Gallon and 50-Gallon drums. If you properly package and ship the minimum requirement to an approved disposal facility, Clean Earth will recycle them free of charge.

- **ALL CYLINDERS MUST BE DEPRESSURIZED PRIOR TO SHIPMENT.** Cylinders that do not have the friable disk or knockout valve removed will not be accepted.
- Cylinders must be properly packaged for shipment to the disposal facility. (See page 2 for packaging guidelines).
- **ONLY standard (#40) cylinders** of CAV-GRIP III, CAV-GRIP PVC, and Flexible DASH Dual Tank cylinders or small (#20) cylinders of CAV-PRIME V-150, CAV-PRIME Low-VOC EPDM and TPO Primer and CAV-PRIME TPO Primer will be accepted at the disposal facility.
- **Large (#85) cylinders of CAV-GRIP III do not qualify for this program and should be recycled by following the procedure described on the cylinder sticker.**
- **Flexible DASH 15-Gallon and 50-Gallon drums must be empty prior to shipment.**
- Shipments must contain at least **the required minimum quantity** or a \$100 fee will be assessed. There is no maximum cap limit for the number of cylinders that can be shipped.



Packaging Type	Minimum Quantity
CAV-GRIP III or CAV-GRIP PVC	12 canisters (#40 cylinders only)
CAV-PRIME V-150, CAV-PRIME Low-VOC EPDM and TPO Primer and CAV-PRIME TPO Primer	26 canisters
Flexible DASH Dual Tanks	12 canisters
Flexible DASH 15-Gallon Drums	9 drums
Flexible DASH 50-Gallon Drums	4 drums

*If minimum container requirements have already been met, empty cylinders of UN-TACK and CAV-PRIME can be included in the shipment.



Cylinder Preparation

Please note that ALL cylinders must go through the following procedure to be accepted at a Clean Earth recycling facility.

Use eye protection and impervious gloves.

- 1 Follow the disposal steps outlined on the Technical Data Bulletin (TDB).
- 2 Once cylinders are empty and vented, carefully puncture the friable disk or knockout valve on the top of the cylinder.
- 3 Cylinders should then be packaged for shipment to the recycling facility. Cylinders are to be placed on a pallet and shrink wrapped or placed in a gaylord shipping box.

Shipping Containers to Clean Earth

Once the shipment of cylinders or drums has been properly prepared, shipping arrangements will need to be made with an LTL carrier. Some national LTL carriers include:

Please note that all packaging, shipping arrangements, and transportation costs are the sole responsibility of the sender, regardless of LTL carrier.

When setting up a shipment with an LTL carrier, the following information will be required:

- The address for pickup of the containers.
- Weight of shipment:
 - each empty cylinder weights between 8.0-9.0lbs
 - each empty 15-Gallon Drum weighs roughly 15lbs
 - each empty 50-Gallon Drum weighs roughly 40lbs
- Dimensions of shipment.
- Designation of shipment is Class 125.
- The address for delivery of the containers. (Select one of the Clean Earth locations listed below.)
